



24/7 Information about Listed Companies

The Nigerian Stock Exchange is committed to bridging the information gap between the exchange and market participants, knowing that the stock market thrives on information. The NSE makes announcements, annual financial reports, quarterly financial reports, trading statistics, report of unscheduled material events or corporate changes and other information about the operations of publicly traded companies available to stakeholder on its website. Some market data are also disseminated to market participants through the NSE's trading platform, X-GEN as well as a growing list of authorized data vendors.



The first port of call for information on NSE's-listed companies is our website (www.nse.com.ng). Brokers and other market participants connected to our trading platform also receive such information via their trading workstations between 10:30am and 2:30pm, Monday through Friday, excluding public holidays.

Key information about NSE-listed companies published on The NSE website are highlighted below.

X-Compliance Report

The X-Compliance Report is a report that is available on the NSE website. It provides compliance related information on all listed companies and it is updated every Friday at the close of business. Information contained in the report includes:

- Early filers of audited accounts
- Delinquent filers of audited accounts
- Delinquent filers of quarterly reports
- Companies slated for delisting/restructuring
- Companies that breached the listings rules of the exchange
- Enforcement actions by the exchange
- Companies that have been granted waivers to comply with the 'free float' requirements
- Applications approved by the Quotations Committee of National Council of the Exchange
- Released financial (list of companies' financials released within the financial year)

To view this report, log-on to the NSE website, move your mouse over the Issuers link on the main navigation and then click on X-Compliance Report under the corporate disclosure sub menu.

Financial News

These are financial reports (interim and audited accounts) and corporate actions from listed companies which are published on the NSE website once they are filed via X-issuer (Issuers Portal). This information is simultaneously disseminated to the traders via X-GEN (between 10:30am and 2:30pm, Monday through Friday, excluding public holidays) and can be obtained from our authorized Market data vendors. To view this report, logon to the NSE website, mouse over the Issuers link on the main navigation and then click on company results under the corporate disclosure sub menu.

Market Bulletin/Company Announcements

These are reports on unscheduled material events or corporate changes, board meetings and other market news which are published on the NSE website, under the corporate disclosures sub menu once they are released. Information in this category is simultaneously disseminated to the traders via X-GEN (between 10:30am and 2:30pm, Monday through Friday, excluding public holidays) and can be obtained from our authorized market data vendors.



Trading Statistics

The NSE provides information on the various securities traded during the course of the day and is published on the NSE website under the market data section. This information is also disseminated by our authorized market data vendors.

Delisted Companies

We provide regular updates on delisted companies. To view this information, logon to the NSE website, move your mouse over the issuer link on the main navigation page and click on delisted companies under the corporate disclosure sub menu to view the full list of delisted companies.

The NSE cannot recommend or endorse any particular market data vendor, its personnel, or its products. But these companies (Thomson Reuters, Bloomberg, Interactive Data, Six Financials, S&P Dow Jones, I-Net Bridge, FactSet Inc., MSCI, Direct FN, Applied Logic Ltd and Infoware Ltd) also publish the above information.

To access these information from Bloomberg terminal for example, simply run the function NH NGR then press <Enter>.
